Council Meeting Minutes
June 21, 2022**

Executive Duties

The Mayor and Council meeting was called to order at 6:00 pm and a quorum was confirmed by Mayor Pro Tem Caylor. The invocation was given by Councilman Williams. Mayor Pro Tem Caylor led the pledge of allegiance.

Consent Agenda

Mayor Pro Tem Caylor made an announcement to amend the presented agenda, to add number 16 regarding the purchase a new sanitation truck.

A motion was made by Councilman Williams to approve the amended agenda, financial reports for May 2022, and minutes for the May 17, 2022, meeting. The motion was seconded by Councilman Pangle and carried unanimously with a 4-0 vote.

New Business

Councilman Williams presented the Public Safety Committee key points for May 2022.

The motion made to accept the purchase of Outdoor Exercise Equipment (5 Stations) by Councilman Pangle, seconded Councilman Williams and voted unanimously with a 4-0 vote. The amount of purchase with shipping and installation will be \$14,786.00.

The Animal Control Ordinance will be tabled until the next meeting in July.

Discussion on paving Cemetery Road ended for lack of motion on the decision.

Approval of Ordinance 2022-06, regulating parking on public streets and right of ways within Patterson Farms Roadways was made by Councilman Roche, seconded by Councilman Lowe, carried unanimously with a 4-0 vote.

Budget amendment in the amount of \$12,200.00 for Watch Guard from the ARP Funds was approved. The motion was made by Councilman Williams, seconded by Councilman Roche and carried unanimously with a 4-0 vote.

Purchase of Radar Speed Signs was approved not to exceed the amount of \$6,500.00 by Councilman Roche, seconded by Councilman Pangle and carried unanimously with a 4-0 vote.

Annexation of Parcel # 11-263-01-188, 137 Santa Fe Loop, Juan & Sylvia Rios, was approved. The motion was made by Councilman Williams, seconded by Councilman Roche, and carried unanimously with a 4-0 vote.

Councilman Williams made the motion for approval of the purchase of a new sanitation truck from a Peterbilt Dealer located in Knoxville, TN, in the amount of \$352,000.00, seconded by Councilman Lowe, carried unanimously with a 4-0 vote.

Public Comment

There being no further business a motion for adjournment was made by Councilman Williams, seconded by Councilman Pangle, and carried unanimously with a 4-0 vote. Meeting adjourned at 6:48pm.
